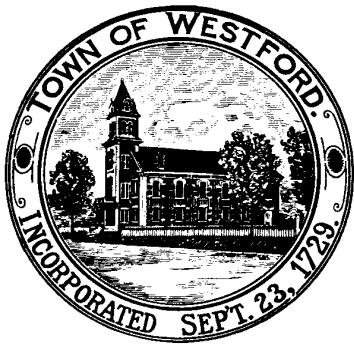

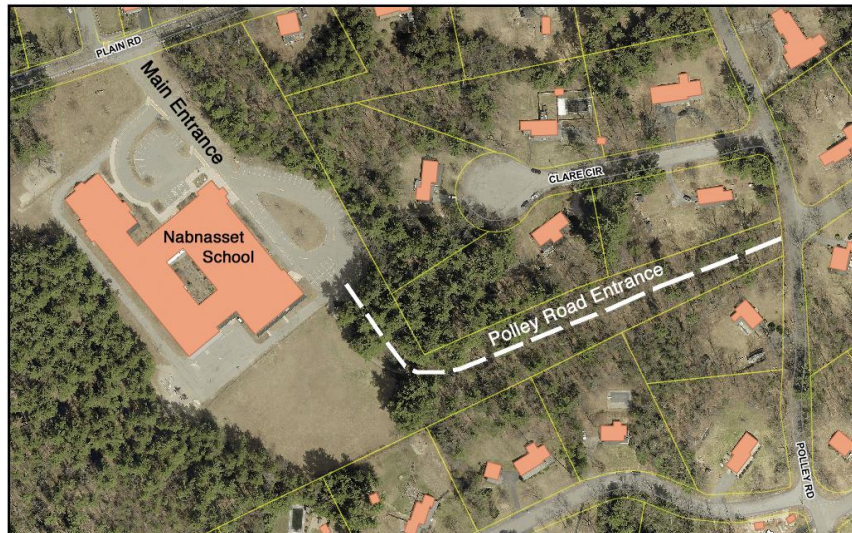

Re: Request repaving of the Polley Road entrance to Nabnasset School

The Commission on Disability and the Healthy Westford Committee are writing jointly to request a repaving of the Polley Road entrance to the Nabnasset School. Principal Susan Dubois is also in support of this request. The old pavement is badly deteriorated and is not accessible for people using a wheelchair, those using a walker or a cane, or even families using a stroller.



This way has been used extensively by parents walking their children to and from the school. Outdoor walking such as this is a main goal of the Healthy Westford Committee. People in this neighborhood have been picking up litter and trimming vegetation as necessary. Our request also asks the town to consider this way as being intended for full accessibility, being a smooth asphalt surface suitable for wheelchairs, walkers, and canes.
